# SOLUTION OF STEFAN PROBLEMS BY FULLY DISCRETE LINEAR SCHEMES 

## A. HANDLOVIČOVÁ


#### Abstract

This paper deals with a class of nonlinear parabolic problems with nonlinear boundary conditions. Stefan problems and porous medium equations are included. The enthalpy formulation and the variational technique are used. Convergence of a fully discrete linear approximation scheme is studied.


## 1. Introduction

In our paper we shall consider the convergence of a fully discrete linear approximation scheme. This scheme can be used in solving nonlinear Stefan-like parabolic problems with nonlinear boundary conditions:

where $\Omega \subset \mathbb{R}^{d}$ is a polygonal convex domain with the boundary $\Gamma, T<\infty, \nu$ is the outward normal to $\Gamma$, the functions $f, g, \beta, k$ are Lipschitz continuous, $\beta: \mathbb{R} \rightarrow \mathbb{R}$ is nondecreasing and $k(s)$ is a positive definite symmetric $d \times d$-matrix for any $s \in \mathbb{R}$.

The use of linear approximation schemes for solving these problems from both the theoretical and numerical point of view has been extensively studied. A linear approximation scheme based on the so-called nonlinear Chernoff formula with constant relaxation parameter $\mu$ was studied in $[\mathbf{1}],[\mathbf{1 2}],[\mathbf{1 4}],[\mathbf{8}]$.

Another linear approximation scheme was investigated in $[\mathbf{5}],[\mathbf{6}],[\mathbf{7}],[\mathbf{3}]$. There the authors used an approximation scheme of the type

[^0]where $\theta_{i}$ is an approximation of the function $\beta(u)$ at time $t_{i}, \mu_{i} \in L_{\infty}(\Omega)$, $0<\delta \leq \mu_{i} \leq K$ and where $K^{-1}, 1-2 \alpha$ and $\delta$ are sufficiently small constants. This scheme has the disadvantage of not being explicit with respect to $\theta_{i}$ and $\mu_{i}$ and therefore some iterative method for determining them must be used. In the papers mentioned above, the convergence and energy error estimates for this semi-discretization scheme were established for both strictly monotone ([5]) and nondecreasing ([7]) function $\beta$. The idea of our linear approximation scheme is similar but we introduce the following two novelties:

- We consider a fully discrete scheme, that means we discretize not only in time, but we also use the finite element method for space discretization.
- We linearize not only the function $\beta$ but also nonlinearities in the right hand side of the equation and the nonlinearity in the boundary condition.

In Subsection 4, we prove the convergence of an iterative method for finding the functions $\mu_{i}, \theta_{i}$ at each time step $t_{i}$. In Subsections 5 and 6 , the convergence of our linear approximation scheme is proved.

Some of our proofs are only sketched; the details can be found in [4].

## 2. Basic Notations, Assumptions and Basic Results of the Finite Element Method

We denote

Further we shall use function spaces in $[\mathbf{1 0}]: L_{2}(\Omega)$ with norm $\|\cdot\|, L_{2}\left(I, L_{2}(\Omega)\right)=$ $L_{2}(Q)$ with norm $\|\cdot\|_{L_{2}\left(I, L_{2}(\Omega)\right)}$ and $H^{1}(\Omega):=W^{1,2}(\Omega)$ with norm $\|\cdot\|_{H}$. We denote the dual space to $H^{1}(\Omega)$ by $H^{*}(\Omega)$. Finally, we shall use function space $L_{2}(\Gamma)$ with norm $\|\cdot\|_{\Gamma}$ and inner product $\langle\cdot, \cdot\rangle_{\Gamma}$. We use the notation $\langle\cdot, \cdot\rangle$ both for the inner product in $L_{2}(\Omega)$ and the duality pairing between $H^{1}(\Omega)$ and $H^{*}(\Omega)$.

We shall assume that:

Let $\left\{S_{h}\right\}_{h}$ be a family of decompositions

of $\Omega$ into closed $d$-simplices so that: $\bar{\Omega}=\cup_{k=1}^{K_{h}} S_{k}$ where $h$ is the mesh size: $h=$ $\sup _{k=1, \ldots, K_{h}} \operatorname{diam} S_{k}$.

We assume that

The assumptions above will be simply denoted by (H), that is

On the boundary $\Gamma$, we define the discrete inner product by:

for any piecewise continuous functions $\psi, \phi$ in $\bar{\Omega}$, where $\Pi_{h}$ stands for the local linear interpolation operator ([2]).

For any $\psi, \varphi \in V_{h}^{1}$, we have ([15]):

The estimate (2.3) holds also for functions $\varphi \in V_{h}^{1}$ and $\psi=b \cdot v$, where $v \in V_{h}^{1}$ and $b \in V_{h}^{0} ;\|b\|_{L_{\infty}} \leq K, K>0$.
We denote by $a(\cdot, \cdot)$ the inner product in $H^{1}(\Omega)$ :

We now introduce $L_{2}$-projection operator $P_{h}^{0}: L_{2}(\Omega) \rightarrow V_{h}^{0}$, which is defined by

We also introduce the discrete $H^{1}$-projection operator $P_{h}^{1}: H^{1}(\Omega) \rightarrow V_{h}^{1}$, which is defined by

We shall use the following well-known facts (see e.g. [13, p. 15].)

We conclude with some notations concerning the time discretization. Let $\tau=\frac{T}{n}$ be the time step and $t_{i}=i \tau, I_{i}=\left(t_{i-1}, t_{i}\right]$ for $1 \leq i \leq n$. We also set $z^{i}:=z\left(\cdot, t_{i}\right)$ or $\bar{z}^{i}:=\frac{1}{\tau} \int_{I_{i}} z(\cdot, t) d t$ for any continuous or integrable (in time) function $z$ defined in $Q$, respectively, and $\partial z^{i}:=\left(z^{i}-z^{i-1}\right) / \tau, 1 \leq i \leq n$ for any given family $\left\{z^{i}\right\}_{i=0}^{n}$. Similarly we denote $\delta u_{i}=\left(u_{i}-u_{i-1}\right) / \tau$ for $i=1, \ldots, n$ and $u_{i}, u_{i-1} \in V_{h}^{0}$.

For simplicity we shall denote $f(s):=f(x, t, s)$ and $g(s):=g(x, t, s)$. By $C$ we denote a generic constant which is independent of time and space discretization $\tau$ and $h$.

## 3. Formulations of Problems

The variational formulation of our problem is as follows.
Problem (P): Find $\{u(t, x), \theta(t, x)\}$ such that

As we have mentioned above, the following approximation scheme is based on the ideas of [5] and [7] (see the approximation scheme in Introduction). The basic idea of this linear scheme consists of determining a variable relaxation parameter $\mu_{i}=\mu_{i}(x)$ to be used in the algebraic correction $u_{i}:=u_{i-1}+\mu_{i}\left(\theta_{i}-\beta\left(u_{i-1}\right)\right)$, $i=1, \ldots, n$, where $\theta_{i}$ is the approximation of $\beta(u)$ at time $t_{i}$. Moreover, the same iterative method for finding functions $\mu_{i}$ and $\theta_{i}$ can be used also for improving the approximation of nonlinearities on the boundary and on the right hand side. In the same way as in the case of the nonlinearity $\beta(u)$ we can use the variable relaxation parameters also for nonlinearities on the boundary (function $g(\beta(u)$ ) and on the right hand side (function $f\left(\beta(u)\right.$ ). We denote these relaxation parameters by $\omega_{i}$ (for the function $g$ ) and $\rho_{i}$ (for the function $f$ ). We use a fully discrete scheme including the finite element method.

Therefore, our discrete problem is of the form:
Problem $\left(P_{h, \tau}\right)$ : For any $1 \leq i \leq n$, find $\left\{u_{i}(x), \theta_{i}(x)\right\}$ such that $u_{i} \in V_{h}^{0}$ and $\theta_{i} \in V_{h}^{1}$, and the functions $\mu_{i}, \rho_{i}$ and $\omega_{i} \in V_{h}^{0}$ which have the following properties:

for $i=1, \ldots, n$, where the "error" functional $p_{i}$ satisfies

Moreover, we have $0<\delta \leq \mu_{i} \leq K,\left|\rho_{i}\right| \leq K,\left|\omega_{i}\right| \leq K$ and $k_{i-1}=k\left(\beta\left(u_{i-1}\right)\right)$ and all members of this matrix are functions from $V_{h}^{0}$. Further $\alpha>0$ and $K^{-1}, 1-2 \alpha, \delta$ are sufficiently small positive constants. By $\|\cdot\|_{L_{2}, \mu_{i}}$ we denote the norm in the weighted $L_{2}$-space with the weight function $\mu_{i}$ (e.g. [10]). This scheme has the disadvantage of not being explicit with respect to $\theta_{i}$ and $\mu_{i}$. We determine the values of the functions $\theta_{i}, \mu_{i}, \rho_{i}, \omega_{i}$ by an iterative process that we describe later.

In case the function $\beta$ is not strictly monotone (e.g. for the Stefan problem), we approximate the function $\beta$ by a strictly monotone Lipschitz continuous function $\beta_{n}$ (with Lipschitz constant $L_{\beta_{n}}$ ), such that

## 4. Convergence of an Iterative Method

As we have mentioned above, the approximate scheme (3.5)-(3.8) has the disadvantage of not being explicit with respect to the functions $\mu_{i}$ and $\theta_{i}$. There are several iterative schemes for solving this problem (see for example [4]). The scheme that we establish in this paper is based on the idea of an iterative method in [11].

Put:

Let $1 \leq i \leq n$ be fixed. Then we define our iterative method as follows:

If $P_{h}^{0} \theta_{i, k}=\beta\left(u_{i-1}\right)$ then $\mu_{i, k}:=\mu_{i, k-1}$ and $\rho_{i, k}:=\rho_{i, k-1}$. Similarly, if $P_{h}^{0}\left(\theta_{i, k}-\right.$ $\left.\theta_{i-1}\right)=0$ then $\omega_{i, k}:=\omega_{i, k-1}$.

The solvability of (4.2)-(4.3) follows from the theory of monotone operators (see [4]).

The sequences $\left\{\mu_{i, k}\right\},\left\{\rho_{i, k}\right\},\left\{\omega_{i, k}\right\},\left\{\theta_{i, k}\right\}$ of iterations help us to find functions $\mu_{i}, \rho_{i}, \omega_{i}, \theta_{i}$ as it is formulated in the following theorem:

Theorem 1. Assume (H). Let $1 \leq i \leq n$ be fixed and $\tau \leq \tau_{0}$, $h \leq h_{0}$ for sufficiently small $\tau_{0}, h_{0}$. If $\left\{\mu_{i, k}\right\},\left\{\rho_{i, k}\right\},\left\{\omega_{i, k}\right\}$ and $\left\{\theta_{i, k}\right\}$ are sequences from (4.2)-(4.3) then there exists index $l \in N$ such that the functions $\mu_{i}:=\mu_{i, l}, \rho_{i}:=$ $\rho_{i, l}, \omega_{i}:=\omega_{i, l}$ from $V_{h}^{0}$ and $\theta_{i}:=\theta_{i, l} \in V_{h}^{1}$ satisfy the equation (3.6) and the inequality (3.7).

Proof.
First we denote $v_{k}=\mu_{i, k}-\tau \rho_{i, k}$. It is obvious that this function is positive for sufficiently small $\tau_{0}$, hence $v_{k} \geq \gamma$ for some $\gamma>0$.

The monotonicity of the sequence $\left\{\mu_{i, k}\right\}$ for $k \geq k_{0}$ implies $\mu_{i, k} \rightarrow \mu$ pointwise in $\Omega$. Since the functions $\mu_{i, k}$ are bounded, we have $\mu_{i, k} \rightarrow \mu$ in $L_{p}(\Omega)$ for all $p>1$.

We can easily prove that the sequence $\left\{\theta_{i, k}\right\}$ is bounded in $H^{1}(\Omega)$ :
In (4.2) we choose as a test function $\psi=\theta_{i, k}$ and after some rearrangement we obtain:

Using the properties of the functions $v_{k}$ and $\omega_{i, k}$, and due also to (2.2), (2.3), (2.4) and (2.6), we have:

& +\tau \frac{k_{0}}{4}\left\|\nabla \theta_{i, k}\right\|^{2}+C \tau\left\|\theta_{i, k}\right\|^{2}+C\left\|\theta_{i-1}\right\|^{2} \\
& +C\left\|f\left(\beta\left(u_{i-1}\right)\right)\right\|^{2}+C\left\|g\left(\theta_{i-1}\right)\right\|_{H}^{2}
\end{aligned}
$$

Now using the properties of the functions $f, g, \theta_{i-1}, \beta\left(u_{i-1}\right)$, we obtain for sufficiently small $h<h_{0}$ :

From the properties of the sequence $\left\{\mu_{i, k}\right\}$ it follows that there exists an index $l$ such that $\left\|\mu_{i, l-1}-\mu_{i, l}\right\|_{L_{p}(\Omega)} \leq C \tau^{\sigma}$ for $\sigma>1$. We set $\theta_{i}:=\theta_{i, l}, \mu_{i}:=\mu_{i, l}$, $\rho_{i}:=\rho_{i, l-1}$ and $\omega_{i}:=\omega_{i, l-1}$. We must only verify, that for these functions, the conditions (3.6) and (3.7) hold. It is clear that $\mu_{i}=\mu_{i, l} \leq \bar{\mu}_{i, l}$ and that is why (3.7) holds.

For $\theta_{i}:=\theta_{i, l}$ the equation (4.2) holds. We have:

& \quad=\left\langle\left(\mu_{i, l}-\mu_{i, l-1}\right)\left(P_{h}^{0} \theta_{i}-\beta\left(u_{i-1}\right), \psi\right\rangle+\tau\left\langle f\left(\beta\left(u_{i-1}\right)\right), \psi\right\rangle-\tau\left\langle g\left(\theta_{i-1}\right), \psi\right\rangle_{h, \Gamma} .\right.
\end{aligned}
$$

We now set $\left\langle p_{i}, \psi\right\rangle=\left\langle\left(\mu_{i, l}-\mu_{i, l-1}\right)\left(P_{h}^{0} \theta_{i}-\beta\left(u_{i-1}\right), \psi\right\rangle\right.$. From the properties of $\mu_{i, k}, P_{h}^{0} \theta_{i}$ and $\beta\left(u_{i-1}\right)$ using generalized Hölder's inequality we obtain that the functional $p_{i}$ satisfies (3.9). This completes the proof.

## 5. Stability of the Discrete Scheme

The problem (3.6)-(3.8) can be rewritten as follows

\quad & \text { for all } \psi \in V_{h}^{1} \text { and }\left\|p_{i}\right\|_{H^{*}(\Omega)}=O\left(\tau^{\sigma}\right)
\end{align*}

Lemma 1. Assume (H). Then for $\tau \leq \tau_{0}$ and $h \leq h_{0}$ such that the equation

= & : V+V I+V I I .
\end{align*}

We shall estimate each resulting term. Some of these terms are similar as in [5] and $[7]$ so we comment them only briefly.

First note that from (3.8) it holds:

& \quad \quad-\sum_{i=1}^{m}\left\langle u_{i}-u_{i-1}, \beta\left(u_{i}\right)-\beta\left(u_{i-1}\right)\right\rangle
\end{aligned}

Further in the same way as in [5] we arrive at

\end{aligned}

Now for sufficiently small $h_{0}$ we get

For the term $V I$, we use the property of $P_{h}^{0}$ and (3.9), (3.8), (2.6):

where $C_{b}$ and $C_{t}$ are constants independent of time and space discretization.
We rearrange the last term of this inequality using (2.4) and the property of $P_{h}^{0} \theta_{i}$ in this way:

\end{aligned}

We add to the both sides of this inequality the term $\frac{k_{0}}{4} \tau\left\|\theta_{m}\right\|^{2}$ and we estimate this term on the right hand side as above:

& \quad \leq C+C \tau \sum_{i=1}^{m}\left\|\beta\left(u_{i}\right)\right\|^{2}+\tau^{2} C h_{0}^{2-\xi} \sum_{i=1}^{m}\left\|\theta_{i}\right\|_{H}^{2}
\end{aligned}
$$

And now for sufficiently small $\tau_{0}$ the assertion (5.3) follows as a consequence of the discrete Gronwall inequality.

Consequence. Let the assumptions of Lemma 1 hold. Then there exists constant $C$, independent of discretization parameters such that:

## 6. Convergence of the Method

We denote $\gamma:=(\tau, h)$ the pair of discretization parameters, where $\tau$ and $h$ have the same meaning as before. Then Rothe's function is defined as follows:

Analogously, we can define also Rothe's and the step function $u^{(\gamma)}(t, x)$ and $\bar{u}^{(\gamma)}(t, x)$, respectively.

We denote the time derivative of Rothe's function $u^{(\gamma)}$ by $u_{t}^{(\gamma)}$. For $t \in\left(t_{i-1}, t_{i}\right)$ we have:

From (5.12), (6.4) and the reflexivity of $L_{2}\left(I, L_{2}(\Omega)\right)$ it follows that there exists $u \in L_{2}\left(I, L_{2}(\Omega)\right)$ and a subsequence $\left\{\gamma_{2}\right\}$ such that $u^{\left(\gamma_{2}\right)} \rightharpoonup u, \bar{u}^{\left(\gamma_{2}\right)} \rightharpoonup u$ in $L_{2}\left(I, L_{2}(\Omega)\right)$ (where we choose $\left\{\gamma_{2}\right\}$ as a subsequence of $\left\{\gamma_{1}\right\}$ ). From the boundedness of $\bar{\theta}^{(\gamma)}$ in $L_{2}\left(I, H^{1}(\Omega)\right.$ ) (see Lemma 1 and its Consequence) and the reflexivity of $L_{2}\left(I, H^{1}(\Omega)\right)$ we obtain weak convergence of some subsequence $\left\{\gamma_{3}\right\}$ (chosen as a subsequence of $\left\{\gamma_{2}\right\}$ ) in this space.

By standard arguments we can obtain the fact that $\theta$ is identical with $\beta(u)$ (see [7], [4]). Lemma 5 implies the existence of $F \in L_{2}\left(I, H^{*}(\Omega)\right)$ and a subsequence $\{\gamma\}$ (chosen from $\left\{\gamma_{3}\right\}$ ), such that $F_{(\gamma)} \rightharpoonup F$ v $L_{2}\left(I, H^{*}(\Omega)\right)$.

We conclude the proof by proving $\frac{d u}{d t}=F$ in $L_{2}\left(I, H^{*}(\Omega)\right)$, that means $\frac{d u(t)}{d t}=$ $F(t)$ for a.a. $t \in I$.

& \quad \leq K\left(\left\|P_{h}^{0} \bar{\theta}^{(\gamma)}\right\|_{L_{2}\left(I, L_{2}(\Omega)\right)}+\left\|\beta\left(\bar{u}^{(\gamma)}\right)\right\|_{L_{2}\left(I, L_{2}(\Omega)\right)}\right) \\
& \quad \times\left(\left\|\bar{\theta}^{(\gamma)}-\beta(u)\right\|_{L_{2}\left(I, L_{2}(\Omega)\right)}+\left\|\beta(u)-P_{h}^{1} \beta(u)\right\|_{L_{2}\left(I, L_{2}(\Omega)\right)}\right)
\end{aligned}
$$

Due to (5.12) and (5.3), we have the boundedness of $\left\{P_{h}^{0} \bar{\theta}(\gamma)\right\}$ and $\left\{\beta\left(\bar{u}^{(\gamma)}\right)\right\}$ and conclusion is analogous as above.

The estimation of the last term is straightforward with respect to the properties of $p_{i}$ for $i=1, \ldots, n$ :

$$
\begin{aligned}
\frac{1}{\tau} \int_{I}\left\langle\bar{p}^{(\gamma)}(t), \bar{\theta}^{(\gamma)}(t)-P_{h}^{1} \beta(u(t))\right\rangle d t & \leq \frac{1}{\tau} \int_{I}\left\|\bar{p}^{(\gamma)}(t)\right\|_{H^{*}}\left\|\bar{\theta}^{(\gamma)}(t)-P_{h}^{1} \beta(u(t))\right\|_{H} d t \\
& \leq C \tau^{\sigma-1}\left\|\bar{\theta}^{(\gamma)}-P_{h}^{1} \beta(u)\right\|_{L_{2}\left(I, H^{1}(\Omega)\right)}^{2}
\end{aligned}
$$

which converges again to zero.
Now we can conclude:

$$
\left\|\nabla\left(\bar{\theta}^{(\gamma)}-\beta(u)\right)\right\|_{L_{2}\left(I, L_{2}(\Omega)\right)}^{2} \rightarrow 0 \text { for } \gamma \rightarrow 0
$$

which together with (6.12) gives the assertion of Lemma.
Consequence. Let the subsequence $\left\{\bar{\theta}^{(\gamma)}\right\}$ be as in Lemma 6. Then it holds:

$$
\bar{\theta}^{(\gamma)} \rightarrow \beta(u) \text { in } L_{2}\left(I, L_{2}(\Gamma)\right) .
$$

Proof. The proof follows in a straightforward way from the imbedding theorem ([10]).

Lemma 8. Assume (H) and let the subsequence $\left\{\bar{\theta}^{(\gamma)}\right\}$ from (6.1) have the properties as above. Let the subsequence $\left\{\bar{\theta}_{\tau}^{(\gamma)}\right\}$ be the same as in the proof of Lemma 7. Then it holds:

$$
\begin{equation*}
\left\|\bar{\theta}_{\tau}^{(\gamma)}-\bar{\theta}^{(\gamma)}\right\|_{L_{2}\left(I, L_{2}(\Gamma)\right)} \rightarrow 0 \text { for } \gamma \rightarrow 0 \tag{6.17}
\end{equation*}
$$

Proof. We use (2.7) for $\varepsilon=\tau^{\frac{1}{3}}$ and the boundedness of $\bar{\theta}^{(\gamma)}, \bar{\theta}_{\tau}^{(\gamma)}$ (see Consequence of Lemma 1). We have

$$
\begin{aligned}
& \int_{I}\left\|\bar{\theta}_{\tau}^{(\gamma)}(t)-\bar{\theta}^{(\gamma)}(t)\right\|_{\Gamma}^{2} d t \\
& \quad \leq C_{10} \tau^{\frac{1}{3}} \int_{I}\left\|\nabla\left(\bar{\theta}_{\tau}^{(\gamma)}(t)-\bar{\theta}^{(\gamma)}(t)\right)\right\|^{2} d t+C_{10} \frac{1}{\tau^{\frac{1}{3}}} \int_{I}\left\|\bar{\theta}_{\tau}^{(\gamma)}(t)-\bar{\theta}^{(\gamma)}(t)\right\|^{2} d t \\
& \quad \leq C \tau^{\frac{1}{3}}+C_{10} \frac{1}{\tau^{\frac{1}{3}}}\left(\int_{0}^{T-\tau}\left\|\bar{\theta}^{(\gamma)}(t+\tau)-\bar{\theta}^{(\gamma)}(t)\right\|^{2} d t+\int_{-\tau}^{0}\left\|\bar{\theta}^{(\gamma)}(t+\tau)\right\|^{2} d t\right) \\
& \quad \leq C \tau^{\frac{1}{6}} \rightarrow 0,
\end{aligned}
$$

where similarly as in Lemma 4 we put $\bar{\theta}^{(\gamma)}:=0$ on $\langle-\tau, 0\rangle$ and then we used (6.7) from Lemma 3, (2.5) and Lemma 1.

Now the main result is:

Theorem 2. Assume (H). Let the ratio between space and time discretization step is as in (5.2). Then there exists a pair of functions $\{u(t, x), \theta(t, x)\}$ which fulfil the relations (3.1)-(3.3) and the variational formulation (3.4). Moreover, there exist subsequences $\left\{\theta^{\bar{\gamma}}\right\},\left\{u^{\bar{\gamma}}\right\}$ of sequences $\left\{\theta^{\gamma}\right\},\left\{u^{\gamma}\right\}$ defined in (6.1) such that

$$
\begin{array}{cl}
u^{\bar{\gamma}} \rightharpoonup u & \text { and } \theta^{\bar{\gamma}} \rightarrow \theta=\beta(u) \quad \text { in } L_{2}\left(I, L_{2}(\Omega)\right), \\
& \bar{\theta}^{\bar{\gamma}} \rightarrow \beta(u) \quad \text { in } L_{2}\left(I, H^{1}(\Omega)\right)
\end{array}
$$

for $\bar{\gamma} \rightarrow 0$.
Proof. Due to Lemma 6 we have the existence of a pair of functions $u(t, x)$, $\theta(t, x)=\beta(u(t, x))$ and subsequences converging to them. Now we must prove that this pair of functions satisfies the variational identity (3.4).

We define

$$
P_{h}^{1} \bar{v}^{i}=\frac{1}{\tau} \int_{I_{i}} P_{h}^{1} v(t) d t, \quad i=1, \ldots, n
$$

for arbitrary $v \in L_{2}\left(I, H^{1}(\Omega)\right)$. Then $P_{h}^{1} \bar{v}^{i}$ belongs to $V_{h}^{1}$. Now we use the same notation as in Lemma 7 and we choose as a test function $P_{h}^{1} \bar{v}^{i}$ for $i=1, \ldots, n$. In an analogous way as in Lemma 7, we can get (we denote subsequences $\{\bar{\gamma}\}$ again by $\{\gamma\})$ :

$$
\begin{align*}
& \int_{I}\left\langle u_{t}^{(\gamma)}( \right.\left.t), P_{h}^{1} v(t)\right\rangle d t+\int_{I}\left\langle k_{\gamma}(t) \nabla \bar{\theta}^{(\gamma)}(t), \nabla\left(P_{h}^{1} v(t)\right)\right\rangle d t  \tag{6.18}\\
&+\int_{I}\left\langle g_{\gamma}\left(\bar{\theta}_{\tau}^{(\gamma)}(t), P_{h}^{1} v(t)\right\rangle_{h, \Gamma} d t\right. \\
&+\int_{I}\left\langle\bar{\omega}^{(\gamma)}(t)\left(\bar{\theta}^{(\gamma)}(t)-\bar{\theta}_{\tau}^{(\gamma)}(t)\right), P_{h}^{1} v(t)\right\rangle_{h, \Gamma} d t \\
&=\int_{I}\left\langle f_{\gamma}\left(\beta\left(\bar{u}_{\tau}^{(\gamma)}(t)\right)\right), P_{h}^{1} v(t)\right\rangle d t \\
&+\int_{I}\left\langle\bar{\rho}^{(\gamma)}(t)\left(P_{h}^{0} \bar{\theta}^{(\gamma)}(t)-\beta\left(\bar{u}_{\tau}^{(\gamma)}(t)\right)\right), P_{h}^{1} v(t)\right\rangle d t \\
&+\frac{1}{\tau} \int_{I}\left\langle\bar{p}^{(\gamma)}(t), P_{h}^{1} v(t)\right\rangle d t
\end{align*}
$$

Now we pass to the limit as $\gamma \rightarrow 0$ :
For the first term we use (6.8), Lemma 6 (6.10):

$$
\int_{I}\left\langle u_{t}^{(\gamma)}(t), P_{h}^{1} v(t)\right\rangle d t=\int_{I}\left\langle F_{\gamma}(t), v(t)\right\rangle d t \rightarrow \int_{I}\left\langle u_{t}(t), v(t)\right\rangle d t
$$

In the second term we use the fact $\bar{\theta}_{\tau}^{(\gamma)} \rightarrow \beta(u)$ in $L_{2}\left(I, L_{2}(\Omega)\right)$ (from Lemma 8), the properties of $k$, relations (6.13) and (6.14), the boundedness $\left\{\bar{\theta}^{(\gamma)}\right\}$ in
$L_{2}\left(I, H^{1}(\Omega)\right)$ and $P_{h}^{1} v \rightarrow v \mathrm{v} L_{2}\left(I, H^{1}(\Omega)\right)$. We have:

$$
\int_{I}\left\langle k_{\gamma}(t) \nabla \bar{\theta}^{(\gamma)}(t), \nabla\left(P_{h}^{1} v(t)\right)\right\rangle d t \rightarrow \int_{I}\langle k(t) \nabla \beta(u(t)), \nabla v(t)\rangle d t
$$

In the third term we use (2.3) and the boundedness of $\bar{\theta}^{(\gamma)}$ in $L_{2}\left(I, L_{2}(\Gamma)\right.$ ) (see Consequence of Lemma 1), $\left(\mathrm{H}_{g}\right)$ and Lemma 8:

$$
\int_{I}\left\langleg _ { \gamma } ( \overline { \theta } _ { \tau } ^ { ( \gamma ) } ( t ) , P _ { h } ^ { 1 } v ( t ) \rangle _ { h , \Gamma } d t \rightarrow \int _ { I } \left\langle g(t, \beta(u(t)), v(t)\rangle_{\Gamma} d t\right.\right.
$$

for $\gamma \rightarrow 0$.
If we use (2.3) and the Consequence of Lemma 1, Lemma 8 and the boundedness of $\bar{\omega}^{(\gamma)}$ for the fourth term, we obtain:

$$
\int_{I}\left\langle\bar{\omega}^{(\gamma)}(t)\left(\bar{\theta}^{(\gamma)}(t)-\bar{\theta}_{\tau}^{(\gamma)}(t)\right), P_{h}^{1} v(t)\right\rangle_{h, \Gamma} d t \rightarrow 0
$$

Similarly, in the fifth term, we use $\left(\mathrm{H}_{f}\right),\left(\mathrm{H}_{\beta}\right)$, Lemma 1 and (6.13):

$$
\int_{I}\left\langle f_{\gamma}\left(\beta\left(\bar{u}_{\tau}^{(\gamma)}(t)\right)\right), P_{h}^{1} v(t)\right\rangle d t \rightarrow \int_{I}\langle f(t, \beta(u(t))), v(t) d t
$$

The next term converges to zero due to the boundedness of $\rho^{(\gamma)}$, Lemma 6, (6.13), the inequality (2.4) and the boundedness of $\bar{\theta}(\gamma)$ in $L_{2}\left(I, H^{1}(\Omega)\right)$.

The last term also converges to zero due to the properties of the functionals $p_{i}$ for $i=1, \ldots, n$ So the pair of functions $u(t, x), \theta(t, x)=\beta(u(t, x))$ satisfies the problem (P). This completes the proof.
