# TIME-DEPENDENT STOKES EQUATIONS WITH MEASURE DATA

We establish the existence of a unique solution of an initial boundary value problem for the nonstationary Stokes equations in a bounded fixed cylindrical domain with measure data. Feedback laws yield the source and its intensity from the partial measurements of the solution in a subdomain.

## 1. Introduction

Let $\Omega$ be a bounded open subset of $\mathbb{R}^{3}$ with a smooth boundary and consider the initial boundary value problem

\mathbf{u}(x, 0)=\mathbf{u}_{0}(x) \quad \text { in } \Omega,
\end{gather*}

where $\mathbf{w}$ is a given solenoidal smooth vector function, $\boldsymbol{\mu}=\left(\mu_{1}, \mu_{2}, \mu_{3}\right)$ is a Radon measure of bounded variation on $\Omega$, and $\mathbf{u}_{0}$ is in $L^{1}(\Omega)$.

Let $\chi$ be a given function in $L^{1}\left(0, T ; L^{1}(G)\right)$ where $G$ is an interior subset of $\Omega$. We associate with (1.1) the cost function

\end{equation*}

The purpose of this paper is twofold:
(1) to establish the existence of a unique weak solution of (1.1),
(2) to determine the source $\boldsymbol{\mu}$ and the intensity of the source $g(t)$ from the partial measurements $\boldsymbol{\chi}$ of the solution $\mathbf{u}$ in a fixed subdomain $G \times$ ( $0, T$ ).

Nonlinear elliptic boundary value problems with Radon measure data have been the subject of extensive investigations by Betta et al. [1], Boccardo and Gallouët [2], Boccardo et al. [3], and others. Parabolic initial boundary value problems in cylindrical domains with Radon measure data were studied by Boccardo and Gallouët [2], Brézis and Friedman [4]. In all the cited works, scalarvalued functions are involved. For vector-valued functions with a constraint imposed on the solution, the generic truncated function used in BoccardoGallouët treatment in [2] does not seem applicable. As is well known, for partial differential equations with measure data, the lower-order terms give rise to difficulties. In this paper, we consider the nonstationary Stokes equations with measure data, the case of the full-time-dependent Navier-Stokes equations is open. Feedback laws for distributed systems of parabolic initial boundary value problems, with data in $L^{2}(Q)$, were obtained by Popa in $[5,6]$ and for interacting controls by the author in [7].

The existence of a unique weak solution of (1.1) is established in Section 2. The value function associated with (1.1) and (1.2) is studied in Section 3. Feedback laws are established in Section 4. The results of this paper seem new.

## 2. Existence theorem

We denote by $M_{b}(\Omega)$ the set of all Radon measures of bounded variation on $\Omega$, by $W^{1, p}(\Omega)$ the usual Sobolev spaces, and by $J_{0}^{1, p}(\Omega)$ the Banach space

with the obvious norm.
Throughout the paper, we assume $\mathbf{w}$ to be in $C(0, T ; C(\Omega)) \cap L^{2}\left(0, T ; J_{0}^{1,2}(\Omega)\right)$. Let $\mathscr{G}$ be a compact convex subset of $L^{2}(0, T)$ and let $\mathscr{U}$ be a convex subset of $M_{b}(\Omega)$, compact in the vague topology, that is, $\left\|\boldsymbol{\mu}_{n}\right\|_{M_{b}(\Omega)} \leq C$, then there exists a subsequence such that $\boldsymbol{\mu}_{n_{k}} \rightarrow \boldsymbol{\mu}$ in the distribution sense in $\Omega$ and $\left\|\boldsymbol{\mu}_{n}\right\|_{M_{b}(\Omega)} \leq C$.

Set

then there exists $\left\{g_{n}, \mathbf{u}_{0}^{n}, \mathbf{f}^{n}, \mathbf{w}^{n}\right\} \in C_{0}^{\infty}(0, T) \times C_{0}^{\infty}(\Omega) \times C^{1}\left(0, T ; C_{0}^{1}(\Omega)\right)$ with $\nabla$. $\mathbf{w}^{n}=0$ such that

Consider the initial boundary value problem

With the approximating system (2.6), we have the following known result.
Lemma 2.1. Let

Then there exists a unique solution $\mathbf{u}_{n}$ of (2.2) in $C^{1}(0, T ; C(\Omega))$ with $\mathbf{u}_{n} \in L^{2}(0, T$; $\left.J_{0}^{1,2}(\Omega) \cap W^{3,2}(\Omega)\right)$ and $\mathbf{u}_{n}^{\prime} \in L^{2}\left(0, T ; L^{2}(\Omega)\right)$.

Since $\mathbf{u}_{n} \in C(Q), \sup _{(x, t) \in Q}\left|u_{j, n}(x, t)\right|=\alpha_{j, n}$ exists. Denote

The constant $C$ is independent of $n$.

With $\mathbf{u}_{n} \in C^{1}(0, T ; C(\Omega))$ and with $\nabla \cdot \mathbf{u}_{n}=0$ in Q , we now consider the testing vector function $\varphi\left(\mathbf{u}_{n}\right)=\left(\varphi\left(u_{n, 1}\right), \ldots, \varphi\left(u_{n, 3}\right)\right)$. It is clear that

It is clear that $\varphi$ maps $L^{2}(\Omega)$ into $J_{0}(\Omega)$ and $W_{0}^{1,2}(\Omega)$ into $J_{0}^{1,2}(\Omega)$. Since

Since $w^{n} \in J_{0}^{1,2}(\Omega)$, we get by integration by parts that

The constant $C$ is independent of $n$ and of the data $\left(g ; \mu ; \mathbf{u}_{0}\right)$. The second assertion of the lemma is now obvious.

## 4. Feedback laws

To establish the feedback laws of problems (1.1) and (1.2), we first establish the existence of a solution of a nonlinear parabolic initial boundary value problem.

\int_{0}^{T}\{V(\mathbf{w} ; t)-V(\mathbf{v} ; t)\} d t \geq \int_{0}^{T}(\mathbf{f}, \mathbf{w}-\mathbf{v}) d t \quad \forall \mathbf{w} \in L^{\infty}\left(0, T ; L^{1}(\Omega)\right) \tag{4.23}
\end{equation*}
$$

It follows that $\mathbf{f} \in \partial V(\mathbf{v} ; t)$.
We now show that it is the unique element of $\partial V(\mathbf{v} ; t)$ with minimum $L^{2}(0, T$; $\left.L^{2}(\Omega)\right)$-norm. Let

$$
\begin{align*}
\mathscr{B}_{\varepsilon}(\mathbf{v})= & \left\{\mathbf{v}^{\varepsilon}: \mathbf{v}^{\varepsilon} \in \mathscr{B}_{C},\left\|\mathbf{v}^{\varepsilon}-\mathbf{v}\right\|_{L^{r}\left(0, T ; J_{0}^{1, r}(\Omega)\right)}\right.  \tag{4.24}\\
& \left.+\left\|\mathbf{v}^{\varepsilon}-\mathbf{v}^{\prime}\right\|_{L^{\infty}\left(0, T ; L^{1}(\Omega)\right)}+\left\|\left(\mathbf{v}^{\varepsilon}-\mathbf{v}\right)^{\prime}\right\|_{\left.L^{r}\left(0, T ; J_{0}^{1, r(r-1)}(\Omega)\right)^{*}\right)} \leq C\right\} .
\end{align*}
$$

Then

$$
\begin{equation*}
\bigcap_{\varepsilon}\left\{\partial V\left(\mathbf{v}^{\varepsilon} ; t\right): \mathbf{v}^{\varepsilon} \in \mathscr{B}_{\varepsilon}(\mathbf{v})\right\} \subset \partial V\left(\mathbf{v}_{n} ; t\right) \tag{4.25}
\end{equation*}
$$

since $\mathbf{v}_{n} \in \mathscr{B}_{\varepsilon}(\mathbf{v})$ for $n \geq n_{0}$. With $\mathbf{f}_{\mathbf{v}_{n}}$ the unique element of $\partial V\left(\mathbf{v}_{n} ; t\right)$ with minimum $L^{2}\left(0, T ; L^{2}(\Omega)\right)$-norm, we obtain

$$
\begin{equation*}
\left\|\mathbf{f}_{\mathbf{v}_{n}}\right\|_{L^{2}\left(0, T ; L^{2}(\Omega)\right)} \leq\left\|\mathbf{f}_{\mathbf{v}^{\varepsilon}}\right\|_{L^{2}\left(0, T ; L^{2}(\Omega)\right)} \quad \forall \mathbf{f}_{\mathbf{v}^{\varepsilon}} \in \partial V\left(\mathbf{v}^{\varepsilon} ; t\right), \forall \varepsilon>0 . \tag{4.26}
\end{equation*}
$$

In particular

$$
\begin{equation*}
\left\|\mathbf{f}_{\mathbf{v}_{n}}\right\|_{L^{2}\left(0, T ; L^{2}(\Omega)\right)} \leq\left\|\mathbf{f}_{\mathbf{v}}\right\|_{L^{2}\left(0, T ; L^{2}(\Omega)\right)} \quad \forall \mathbf{f}_{\mathbf{v}} \in \partial V(\mathbf{v} ; t) \tag{4.27}
\end{equation*}
$$

Thus,

$$
\begin{equation*}
\|f\|_{L^{2}\left(0, T ; L^{2}(\Omega)\right)} \leq\left\|\mathbf{f}_{\mathbf{v}}\right\|_{L^{2}\left(0, T ; L^{2}(\Omega)\right)} \quad \forall \mathbf{f}_{\mathbf{v}} \in \partial V(\mathbf{v} ; t) \tag{4.28}
\end{equation*}
$$

Since $\partial V(\mathbf{v} ; t)$ is a closed convex subset of $L^{2}\left(0, T ; L^{2}(\Omega)\right), \mathbf{f}$ is the unique element of minimum $L^{2}\left(0, T ; L^{2}(\Omega)\right)$-norm of the set.
(4) Since $\mathscr{L}$ is a compact linear mapping of $L^{\infty}(\Omega)$ into $C_{0}(\Omega)$, we have

$$
\begin{equation*}
\mathscr{L}\left(\int_{0}^{T} \mathbf{f}_{\mathbf{v}_{n}}(x, t) d t\right) \rightarrow \mathscr{L}\left(\int_{0}^{T} \mathbf{f}(x, t) d t\right) \quad \text { in } C_{0}(\Omega) \tag{4.29}
\end{equation*}
$$

On the other hand,

$$
\begin{equation*}
\boldsymbol{\mu}_{n}\left(\mathscr{L}\left(\int_{0}^{T} \mathbf{f}_{\mathbf{v}_{n}} d t\right)\right)=k^{*}\left(\mathscr{L}\left\{\int_{0}^{T} \mathbf{f}_{\mathrm{v}_{n}} d t\right\}\right) \tag{4.30}
\end{equation*}
$$

Since $\boldsymbol{\mu}_{n} \in \mathscr{U}$ and $\boldsymbol{\mu}_{n} \rightarrow \boldsymbol{\mu}$ in $\mathscr{D}^{\prime}(\Omega)$, we get

$$
\begin{equation*}
\left|\boldsymbol{\mu}_{n}\left\{\mathscr{L}\left(\int_{0}^{T}\left(\mathbf{f}_{\mathbf{v}_{n}}-\mathbf{f}\right) d t\right)\right\}\right| \leq C| | \mathbf{f}_{\mathbf{v}_{n}}-\mathbf{f} \|_{L^{\infty}\left(0, T ; C_{0}(\Omega)\right)} \tag{4.31}
\end{equation*}
$$

Thus,

$$
\begin{equation*}
\boldsymbol{\mu}_{n}\left\{\mathscr{L}\left(\int_{0}^{T}\left(\mathbf{f}_{\mathbf{v}_{n}}-\mathbf{f}\right) d t\right)\right\} \rightarrow 0 \tag{4.32}
\end{equation*}
$$

Since $\mu_{n} \rightarrow \boldsymbol{\mu}$ in $\mathscr{D}^{\prime}(\Omega)$, it follows that

$$
\begin{equation*}
\boldsymbol{\mu}_{n}\left\{\mathscr{L}\left(\int_{0}^{T} \mathbf{f}_{\mathbf{v}_{n}} d t\right)\right\} \rightarrow \boldsymbol{\mu}\left\{\mathscr{L}\left(\int_{0}^{T} \mathbf{f} d t\right)\right\} \tag{4.33}
\end{equation*}
$$

It is now clear that

$$
\begin{equation*}
\boldsymbol{\mu}\left\{\mathscr{L}\left(\int_{0}^{T} \mathbf{f} d t\right)\right\}=k^{*}\left(\mathscr{L}\left\{\int_{0}^{T} \mathbf{f} d t\right\}\right) \tag{4.34}
\end{equation*}
$$

We deduce that $\mathbf{u} \in \mathscr{A}(\mathbf{v})$. The lemma is proved.
Proof of Theorem 4.1. (1) It follows from Lemmas 4.2 and 4.3 that the nonlinear mapping $\mathscr{A}$ satisfies all the hypotheses of the Kakutani fixed-point theorem and thus there exists $\tilde{\mathbf{u}}$ such that $\tilde{\mathbf{u}} \in \mathscr{A}(\tilde{\mathbf{u}})$. We now show that

$$
\begin{equation*}
V\left(\mathbf{u}_{0} ; 0\right)=\int_{0}^{T} \int_{G}|\tilde{\mathbf{u}}(x, t)-\chi(x, t)| d x d t \tag{4.35}
\end{equation*}
$$

(2) We know that $\tilde{\mathbf{u}} \in L^{\infty}\left(0, T ; L^{1}(\Omega)\right)$, and thus $\tilde{\mathbf{u}}(x, t)$ is in $L^{1}(\Omega)$ for almost all $t$. Let $\{g, \boldsymbol{\mu}\}$ be in $\mathscr{G} \times \mathscr{U}$ and consider the initial boundary value problem

$$
\begin{gather*}
\mathbf{u}^{\prime}-v \Delta \mathbf{u}+\mathbf{w} \cdot \nabla \mathbf{u}=\nabla p+g \boldsymbol{\mu} \quad \text { in } \Omega \times(t, T), \\
\nabla \cdot \mathbf{u}=0 \quad \text { in } \Omega \times(t, T), \\
\mathbf{u}(x, t)=0 \quad \text { on } \partial \Omega \times(t, T),  \tag{4.36}\\
\mathbf{u}(x, t)=\tilde{\mathbf{u}}(x, t) \quad \text { in } \Omega .
\end{gather*}
$$

From Theorem 2.5, we deduce the existence of a unique solution $\mathbf{u}$ in $L^{\infty}(t, T$; $\left.L^{1}(\Omega)\right) \cap L^{r}\left(t, T ; J_{0}^{1, r}(\Omega)\right)$ with $\mathbf{u}^{\prime}$ in $L^{r}\left(t, T ;\left(J_{0}^{1, r /(r-1)}(\Omega)\right)^{*}\right)$. Let

$$
\begin{equation*}
V(\tilde{\mathbf{u}}(\cdot, t) ; t)=\inf \left\{\int_{t}^{T} \int_{G}|\mathbf{u}(x, s)-\boldsymbol{\chi}(x, s)| d x d s, \forall g \in \mathscr{G}, \forall \boldsymbol{\mu} \in \boldsymbol{u}\right\} . \tag{4.37}
\end{equation*}
$$

Using a minimizing sequence, we deduce that there exists $\{\hat{\mathbf{u}}, \hat{\mathcal{g}}, \hat{\boldsymbol{\mu}}\}$ such that

$$
\begin{equation*}
V(\tilde{\mathbf{u}}(\cdot, t) ; t)=\int_{t}^{T} \int_{G}|\hat{\mathbf{u}}(x, s)-\chi(x, s)| d x d s \tag{4.38}
\end{equation*}
$$

The solution $\hat{\mathbf{u}}$ of (4.36) with the controls $\hat{g}, \hat{\boldsymbol{\mu}}$ depends on $t$ through its interval of definition.

972 Time-dependent Stokes equations with measure data
The dynamic programming principle gives
$\begin{aligned} V(\tilde{\mathbf{u}}(\cdot, t) ; t)=\inf & \left\{V(\mathbf{u}(\cdot, t+h) ; t+h)+\int_{t}^{t+h} \int_{G}|\mathbf{u}(x, s)-\chi(x, s)| d x d s:\right. \\ \mathbf{u} & \left.\text { is a solution of (4.36) with } \mathbf{u}(x, 0)=\mathbf{u}_{0}, \forall\{g, \boldsymbol{\mu}\} \in \mathscr{G} \times \boldsymbol{U}\right\} .\end{aligned}$

Since $\hat{\mathbf{u}}(x, t)=\tilde{\mathbf{u}}(x, t)$, it follows that

$$
\begin{align*}
V(\tilde{\mathbf{u}}(\cdot, t) ; t) & =V(\hat{\mathbf{u}}(\cdot, t) ; t) \\
& \leq V(\hat{\mathbf{u}}(\cdot, t+h) ; t+h)+\int_{t}^{t+h} \int_{G}|\hat{\mathbf{u}}(x, s)-\chi(x, s)| d x d s \tag{4.40}
\end{align*}
$$

Thus,

$$
\begin{equation*}
\int_{t+h}^{T} \int_{G}|\hat{\mathbf{u}}(x, s)-\chi(x, s)| d x d s \leq V(\hat{\mathbf{u}}(\cdot, t+h) ; t+h) \tag{4.41}
\end{equation*}
$$

It follows from the definition of the value function that

$$
\begin{equation*}
V(\hat{\mathbf{u}}(\cdot, t+h) ; t+h)=\int_{t+h}^{T} \int_{G}|\hat{\mathbf{u}}(x, s)-\chi(x, s)| d x d s \tag{4.42}
\end{equation*}
$$

Hence,
$V(\hat{\mathbf{u}}(\cdot, t+h) ; t+h)-V(\hat{\mathbf{u}}(\cdot, t) ; t)=-\int_{t}^{t+h} \int_{G}|\hat{\mathbf{u}}(x, s)-\chi(x, s)| d x d s$.
Therefore,

$$
\begin{equation*}
\frac{d}{d t} V(\hat{\mathbf{u}}(\cdot, t) ; t)=-\int_{G}|\hat{\mathbf{u}}(x, t)-\chi(x, t)| d x \tag{4.44}
\end{equation*}
$$

But, $\tilde{\mathbf{u}}(x, t)=\hat{\mathbf{u}}(x, t)$ in $\Omega$ and therefore

$$
\begin{equation*}
\frac{d}{d t} V(\hat{\mathbf{u}}(\cdot, t) ; t)=-\int_{G}|\tilde{\mathbf{u}}(x, t)-\chi(x, t)| d x . \tag{4.45}
\end{equation*}
$$

It follows that

$$
\begin{equation*}
V(\hat{\mathbf{u}}(\cdot, T) ; T)-V(\hat{\mathbf{u}}(\cdot ; 0) ; 0)=-V\left(\mathbf{u}_{0} ; 0\right)=-\int_{0}^{T} \int_{G}|\tilde{\mathbf{u}}(x, s)-\chi(x, s)| d x d s \tag{4.46}
\end{equation*}
$$

The theorem is proved.
