ON A CLASS OF NONLINEAR REACTION-DIFFUSION SYSTEMS WITH NONLOCAL BOUNDARY CONDITIONS

We prove the existence, uniqueness, and continuous dependence of a generalized solution of a nonlinear reaction-diffusion system with only integral terms in the boundaries. We first solve a particular case of the problem by using the energy-integral method. Next, via an iteration procedure, we derive the obtained results to study the solvability of the stated problem.

1. Introduction

In the recent years, a new attention has been given to reaction-diffusion systems which involve an integral over the spatial domain of a function of the desired solution on the boundary conditions; see [2, 5, 7, 6, 9, 10, 17, 18, 19, 20, 22] and the references cited therein. Most of the studied problems in the current literature are devoted to problems which combine a classical boundary condition (Dirichlet, Neumann, etc.) with an integral condition for single linear equations. The purpose of this paper is to prove the existence and uniqueness of a solution for the following nonlinear reaction-diffusion system with only integral conditions:

(1.1)

for $(x,t) \in Q$, where $Q = \Omega \times I$, $\Omega = (\alpha, \beta)$, is an open bounded interval of \mathbb{R} , I = (0, T) with $0 < T < +\infty$, and f_1, f_2, u_0, v_0, m_k , and μ_k (k = 0, 1) are known functions.

Analogous systems with Dirichlet conditions have been studied in [1, 12, 13, 14, 16]. The existence of solutions have been obtained under the following assumptions:

(A1) the positivity of the solution is preserved with time, which is ensured by

$$f_1(x,t,0,v) \ge 0, \qquad f_1(x,t,u,0) \ge 0,$$
 (1.2)

for a.e. $(x, t) \in Q$, for all $u, v \ge 0$, and $u_0, v_0 \ge 0$;

(A2) the total mass of the components u, v is controlled with time, which is ensured by

$$f_1 + f_2 \le L_1(u + v + 1) \quad \forall u, v \ge 0, \text{ a.e. } (x, t) \in Q;$$
 (1.3)

(A3) the function f_1 verifies

$$f_1 \le L_2(u+v+1) \quad \forall u, v \ge 0, \text{ a.e. } (x,t) \in Q,$$
 (1.4)

where L_1 and L_2 are positive constants.

However, in this paper, we will show the solvability of problem (1.1) without assuming conditions (A1), (A1), and (A3), and we will consider only the Lipschitz condition which will be explicitly given later.

The plan of the paper is as follows. In Section 2, we give some notations used throughout the paper. Section 3 is devoted to the solvability of a particular case of problem (1.1). In Section 3.1, we start by giving the statement of the problem. The concept of the solution we are considering is given in Section 3.2. Then we prove the uniqueness and continuous dependence in Section 3.3. Section 3.4 is reserved to the proof of the existence of the solution. In Section 4, we study problem (1.1). In Section 4.1, we reduce problem (1.1) to an equivalent form which is easier to analyze. The weak formulation of the reduced problem is given in Section 4.2. The existence of the solution is presented in Section 4.3. The uniqueness is established in Section 4.4, while the continuous dependence upon the data is treated in Section 4.5. Finally, we give a conclusion and more results on its generalization.

2. Notation

Let $L^2(\Omega)$ be the usual space of square integrable functions; its scalar product is denoted by (\cdot, \cdot) and its associated norm by $\|\cdot\|$. We denote by $C_0(\Omega)$ the space of continuous functions with compact support in Ω .

Definition 2.1. Denote by $B_2^m(\Omega)$ the Hilbert space defined as a completion of $C_0(\Omega)$ for the scalar product

$$(z,w)_{B_2^m(\Omega)} := \int_{\Omega} \mathfrak{I}_x^m z \cdot \mathfrak{I}_x^m w \, dx, \qquad (2.1)$$

where $\mathfrak{I}_x^m z := \int_{\alpha}^x ((x - \xi)^{m-1} / (m-1)!) z(\xi) d\xi$. By the norm of function *z* from $B_2^m(\Omega)$, the nonnegative number

$$\|z\|_{B_{2}^{m}(\Omega)} := \left(\int_{\Omega} \left(\mathfrak{I}_{x}^{m} z\right)^{2} dx\right)^{1/2} < \infty$$
(2.2)

is understood.

Then, the inequality

$$\|z\|_{B_{2}^{m}(\Omega)}^{2} \leq \frac{(\beta - \alpha)^{2}}{2} \|z\|_{B_{2}^{m-1}(\Omega)}^{2}, \quad m \geq 1,$$
(2.3)

holds for every $z \in B_2^{m-1}(\Omega)$, and the embedding

$$B_2^{m-1}(\Omega) \hookrightarrow B_2^m(\Omega) \tag{2.4}$$

is continuous. If m = 0, the space $B_2^0(\Omega)$ coincides with $L^2(\Omega)$.

Remark 2.2. Note that the space $B_2^m(\Omega)$ was first introduced by the author (see, e.g., [2, 3, 7, 8]). It is a very useful space for this class of problems.

Definition 2.3. Denote by $L_0^2(\Omega)$ the space consisting of elements z(x) of the space $L^2(\Omega)$ verifying $\int_{\Omega} x^k z(x) dx = 0$ (k = 0, 1).

Remark 2.4. Since $L_0^2(\Omega)$ is the null space of the continuous linear mapping $\ell : L^2(\Omega) \to \mathbb{R}^2$, $z \mapsto \ell(z) = (\int_{\Omega} z(x) dx, \int_{\Omega} xz(x) dx)$, it is a closed linear subspace of $L^2(\Omega)$; consequently, $L_0^2(\Omega)$ is a Hilbert space for (\cdot, \cdot) .

Let *X* be a Hilbert space with a norm denoted by $\|\cdot\|_X$.

Definition 2.5. (i) Denote by $L^2(I;X)$ the set of all measurable abstract functions $u(\cdot,t)$ from *I* into *X* such that

(ii) Let $C(\overline{I};X)$ be the set of all continuous functions $u(\cdot,t):\overline{I} \to X$ with

We assume that

- (A4) $0 < c_0 \le a_i \le c_1$, $|\partial a_i/\partial t| \le c_2$, $|\partial a_i/\partial x| \le c_3$, $|b_i| \le c_4$ (i = 1, 2) for all $(x, t) \in \overline{Q}$;
- (A5) the functions f_i (i = 1, 2) are bounded in $B_2^1(\Omega)$ and fulfill the Lipschitz condition, that is, there exists a positive constant *L* such that

$$||f_{i}(\cdot,t,p_{1},q_{1}) - f_{i}(\cdot,t,p_{2},q_{2})||_{B_{2}^{1}(\Omega)} \leq L\Big(||p_{1} - p_{2}||_{B_{2}^{1}(\Omega)} + ||q_{1} - q_{2}||_{B_{2}^{1}(\Omega)}\Big);$$

(A6) we have the following compatibility conditions:

$$\int_{\Omega} x^k u_0(x) dx = m_k(0), \quad \int_{\Omega} x^k v_0(x) dx = \mu_k(0) \quad (k = 0, 1).$$

3. A particular case

3.1. Statement of the problem. In this section, we deal with a particular case of problem (1.1) in which the system is reduced to a single linear equation related to the first component. Precisely, we consider the problem of finding a function u = u(x, t) satisfying

$$\mathcal{L}u = \frac{\partial u}{\partial t} - \frac{\partial}{\partial x} \left(a(x,t) \frac{\partial u}{\partial x} \right) + b(x,t)u = f(x,t), \quad (x,t) \in Q,$$
$$\ell u = u(x,0) = u_0(x), \quad x \in \Omega,$$
$$\int_{\Omega} x^k u(x,t) dx = m_k(t) \quad (k = 0,1), \ t \in I,$$
(3.1)

with

$$\int_{\Omega} x^k u_0(x) dx = m_k(0) \quad (k = 0, 1),$$
(3.2)

where functions a and b verify the same assumptions on a_i and b_i , respectively, given in (A4). Problem (3.1) arises from some practical phenomena such as the identification of the entropy in the quasistatic flexure of a thermoelastic rod [7].

We start by reducing problem (3.1) with inhomogeneous integral conditions to an equivalent problem with homogeneous conditions. In order to achieve this, we introduce a new unknown function *z* defined by z(x,t) = u(x,t) - U(x,t), where

$$U(x,t) = \frac{((\beta - \alpha)^3 + 12(\beta^2 - \alpha^2)(x - \alpha) - 18(\beta + \alpha)(x - \alpha)^2)}{(\beta - \alpha)^4} m_0(t) + \frac{12(3(x - \alpha)^2 - 2(\beta - \alpha)(x - \alpha))}{(\beta - \alpha)^4} m_1(t).$$

Therefore, problem (3.1) becomes

$$\mathscr{L}z = \frac{\partial z}{\partial t} - \frac{\partial}{\partial x} \left(a(x,t) \frac{\partial z}{\partial x} \right) + b(x,t)z = f(x,t), \quad (x,t) \in Q,$$
(3.4a)

$$\ell z = z(x,0) = z_0(x), \quad x \in \Omega, \tag{3.4b}$$

$$\int_{\Omega} x^{k} z(x,t) dx = 0, \quad k = 0, 1, \ t \in I,$$
(3.4c)

with

$$\int_{\Omega} x^k z_0(x) dx = 0, \quad k = 0, 1,$$
(3.5)

where $f(x,t) = f(x,t) - \mathcal{L}U$ and $z_0(x) = u_0(x) - U(x,0)$.

3.2. A strongly generalized formulation. In this section, we make precise the concept of the solution of problem (3.4) we are considering.

Following the energy-integral method [21], we reformulate problem (3.4) as the problem of solving the operator equation

$$Lz = \{f, z_0\}, \tag{3.6}$$

where *L* is an unbounded operator which maps z(x,t) to the pair of elements $\mathcal{L}z$ and ℓz so that $L = \{\mathcal{L}, \ell\}$. The operator *L*, with domain D(L), acts from the space *B* into the space *F*, where D(L) is the set of all elements *z* for which $\partial z/\partial t$, $\partial z/\partial x$, $\partial^2 z/\partial x^2 \in L^2(I; L^2(\Omega))$ and satisfying conditions (3.4c), *B* is a Banach space obtained by enclosing the set D(L) with respect to the norm

$$\|z\|_{B} = \left(\left\| \frac{\partial z}{\partial t} \right\|_{L^{2}(I; B^{1}_{2}(\Omega))}^{2} + \|z\|_{C(\overline{I}; L^{2}(\Omega))}^{2} \right)^{1/2},$$
(3.7)

and F is the Hilbert space $L^2(I; L^2(\Omega)) \times L^2(\Omega)$ consisting of all elements $\{f, z_0\}$ for which the norm

$$\left\|\left\{f, z_{0}\right\}\right\|_{F}^{2} = \left\|f\right\|_{L^{2}(I; L^{2}(\Omega))}^{2} + \left\|z_{0}\right\|^{2}$$
(3.8)

is finite. We denote by \overline{L} the closure of *L*, and by $D(\overline{L})$, the domain of \overline{L} .

Definition 3.1. The solution of the operator equation

$$\overline{L}z = \{f, z_0\} \tag{3.9}$$

is called a strongly generalized solution of problem (3.4) or of equation (3.6).

Remark 3.2. A strongly generalized solution in the sense of Definition 3.1 is also a weak solution (see, e.g., [11]).

3.3. Uniqueness and continuous dependence on the solution. In this section, we establish an energy inequality for *L*. Then, uniqueness and continuous dependence are a direct corollary of it.

THEOREM 3.3. Under assumption (A1), there exists some positive constant C independent of z such that

$$\|z\|_{B} \le C \|Lz\|_{F}.$$

Proof. Considering the scalar product in $B_2^1(\Omega)$ of (3.4a) and $\partial z/\partial t$, and integrating the result over $(0, \tau)$ with $0 \le \tau \le T$, we have

$$\int_{0}^{\tau} \left\| \frac{\partial z(\cdot,t)}{\partial t} \right\|_{B_{2}^{1}(\Omega)}^{2} dt - \int_{0}^{\tau} \left(\frac{\partial}{\partial x} \left(a \frac{\partial z(\cdot,t)}{\partial x} \right), \frac{\partial z(\cdot,t)}{\partial t} \right)_{B_{2}^{1}(\Omega)} dt + \int_{0}^{\tau} \left(bz(\cdot,t), \frac{\partial z(\cdot,t)}{\partial t} \right)_{B_{2}^{1}(\Omega)} dt = \int_{0}^{\tau} \left(f(\cdot,t), \frac{\partial z(\cdot,t)}{\partial t} \right)_{B_{2}^{1}(\Omega)} dt.$$

From integration by parts, we know that

$$-\int_{0}^{\tau} \left(\frac{\partial}{\partial x} \left(a\frac{\partial z(\cdot,t)}{\partial x}\right), \frac{\partial z(\cdot,t)}{\partial t}\right)_{B_{2}^{1}(\Omega)} dt$$

$$= \frac{1}{2} \int_{\Omega} a(x,\tau) \left(z(x,\tau)\right)^{2} dx - \frac{1}{2} \int_{\Omega} a(x,0) \left(z_{0}(x)\right)^{2} dx \qquad (3.12)$$

$$-\frac{1}{2} \int_{0}^{\tau} \int_{\Omega} \frac{\partial a(x,t)}{\partial t} z^{2} dx dt + \int_{0}^{\tau} \left(\frac{\partial a}{\partial x} z(\cdot,t), \mathfrak{I}_{x} \frac{\partial z(\cdot,t)}{\partial t}\right) dt.$$

So, it is easy to see that

$$2\int_{0}^{\tau} \left\| \frac{\partial z(\cdot,t)}{\partial t} \right\|_{B_{2}^{1}(\Omega)}^{2} dt + \int_{\Omega} a(x,\tau) (z(x,\tau))^{2} dx$$

$$= 2\int_{0}^{\tau} \left(f(\cdot,t), \frac{\partial z(\cdot,t)}{\partial t} \right)_{B_{2}^{1}(\Omega)} dt + \int_{\Omega} a(x,0) (z_{0}(x))^{2} dx$$

$$+ \int_{0}^{\tau} \int_{\Omega} \frac{\partial a(x,t)}{\partial t} z^{2} dx dt - 2\int_{0}^{\tau} \left(\frac{\partial a}{\partial x} z(\cdot,t), \mathfrak{I}_{x} \frac{\partial z(\cdot,t)}{\partial t} \right) dt$$

$$- 2\int_{0}^{\tau} \left(bz(\cdot,t), \frac{\partial z(\cdot,t)}{\partial t} \right)_{B_{2}^{1}(\Omega)} dt.$$
(3.13)

Taking into account (A4) and applying the Cauchy inequality to the first and the last two terms on the right-hand side of (3.13), we obtain

$$\int_{0}^{\tau} \left\| \frac{\partial z(\cdot,t)}{\partial t} \right\|_{B_{2}^{1}(\Omega)}^{2} dt + \left\| z(\cdot,\tau) \right\|^{2} \leq c_{5} \left(\int_{0}^{\tau} \left\| f(\cdot,t) \right\|^{2} dt + \left\| z_{0} \right\|^{2} \right) + c_{6} \int_{0}^{\tau} \left\| z(\cdot,t) \right\|^{2} dt,$$
(3.14)

where $c_5 = \max((\beta - \alpha)^2, c_1)/\min(1/2, c_0)$ and $c_6 = \max(c_2 + 2c_3^2 + (\beta - \alpha)^2 c_4^2)/\min(1/2, c_0)$. Using a lemma of Gronwall's type to eliminate the last integral on the right-hand side of (3.14), it yields

$$\int_{0}^{\tau} \left\| \frac{\partial z(\cdot,t)}{\partial t} \right\|_{B_{2}^{1}(\Omega)}^{2} dt + \left\| z(\cdot,\tau) \right\|^{2} \le c_{5} \exp\left(c_{6}T\right) \left(\int_{0}^{T} \left\| f(\cdot,t) \right\|^{2} dt + \left\| z_{0} \right\|^{2} \right).$$
(3.15)

Since the right-hand side of (3.15) is independent of τ , we replace the left-hand side by the upper bound with respect to τ from 0 to *T*. Thus inequality (3.10) holds, with $C = c_5^{1/2} \exp(c_6 T/2)$.

PROPOSITION 3.4. The operator $L: B \rightarrow F$ possesses a closure.

For the proof, we refer the reader to [6].

Since the points of the graph of \overline{L} are limits of sequences of points of the graph of *L*, inequality (3.10) can be extended for operator \overline{L} , that is,

$$\|z\|_{B} \le C \|\overline{L}z\|_{F} \quad \forall u \in D(\overline{L}), \tag{3.16}$$

from which we have the following results.

COROLLARY 3.5. The strongly generalized solution of problem (2.4) if it exists is unique and depends continuously on $(f, u_0) \in F$.

Proof. This can be obtained directly from estimate (3.16).

COROLLARY 3.6. The range $R(\overline{L})$ of \overline{L} is closed in F and $R(\overline{L}) = R(L)$.

Proof. Similar to that in [6].

3.4. Existence of the solution. We now prove the existence of the solution of problem (3.4) in the sense of Definition 3.1.

THEOREM 3.7. Let assumption (A4) be satisfied. Then for any $f \in L^2(I; L^2(\Omega))$ and $z_0 \in L^2(\Omega)$, there exists a unique strongly generalized solution $z = \overline{L}^{-1} \{f, z_0\} = \overline{L}^{-1} \{f, z_0\}$ of problem (3.4).

Proof. It follows from Corollary 3.6 that to prove the existence of the solution, it remains to show that R(L) is everywhere dense in F. To this end, we first establish the density for the special case when the operator L is reduced to L_0 with domain $D(L_0) = D(L)$, where $L_0 = (\mathcal{L}_0 z, \ell z)$, \mathcal{L}_0 is the principal part of \mathcal{L} , that is,

$$\mathscr{L}_0 z = \frac{\partial z}{\partial t} - \frac{\partial}{\partial x} \left(a(x,t) \frac{\partial z}{\partial x} \right).$$
(3.17)

PROPOSITION 3.8. Let the assumptions of Theorem 3.7 hold. If

$$(\mathscr{L}_0 z, \omega)_{L^2(I; L^2(\Omega))} = 0 \tag{3.18}$$

for some $\omega \in L^2(I; L^2(\Omega))$ and for all $u \in D_0(L_0) = \{z \in D(L_0) : \ell z = 0\}$, then ω vanishes almost everywhere in Q.

We assume for the moment that the proof of Proposition 3.8 has been established, and return to the proof of Theorem 3.7.

Suppose that for some $W = (\omega, \omega_0) \in F$ and all $z \in D(L_0)$,

$$(\mathscr{L}_0 z, \omega)_{L^2(I; L^2(\Omega))} + (\ell z, \omega_0) = 0.$$
(3.19)

We must prove that $W \equiv 0$. To this end, putting $z \in D_0(L_0)$ in the last equality, we obtain (3.18). Hence, Proposition 3.8 implies that $\omega \equiv 0$. Thus it follows that

$$(\ell z, \omega_0) = 0, \quad z \in D(L_0).$$
 (3.20)

Since the range $R(\ell)$ is dense in $L^2(\Omega)$, the last equality implies that $\omega_0 \equiv 0$. Hence, $W \equiv 0$.

The general result may be derived by means of the continuity method with respect to the parameter (see, for instance, [5, Proof of Theorem 3]).

To complete the proof of Theorem 3.7, it remains to prove Proposition 3.8.

Proof of Proposition 3.8. Identity (3.18) can be written in the form

$$\left(\frac{\partial z}{\partial t},\omega\right)_{L^2(I;L^2(\Omega))} = \left(\frac{\partial}{\partial x}\left(a(x,t)\frac{\partial z}{\partial x}\right),\omega\right)_{L^2(I;L^2(\Omega))}.$$

In equality (3.21), we put

$$z = \int_0^t e^{c\tau} y(x,\tau) d\tau, \qquad (3.22)$$

where c is a constant such that

$$cc_0 - c_2 - c_3^2 \ge 0, \tag{3.23}$$

 $\mathfrak{I}_t(e^{c\tau}y), \, \partial\mathfrak{I}_t(e^{c\tau}y)/\partial x, \, (\partial/\partial x)(a(x,t)(\partial\mathfrak{I}_t(e^{c\tau}y)/\partial x))$ are in $L^2(I;L^2(\Omega))$, and y satisfy conditions (3.4c).

Substituting (3.22) into (3.21), we have

$$(e^{ct}y,\omega)_{L^2(I;L^2(\Omega))} = \left(\frac{\partial}{\partial x}\left(a\frac{\partial\mathfrak{I}_t(e^{c\tau}y)}{\partial x}\right),\omega\right)_{L^2(I;L^2(\Omega))}.$$
(3.24)

The left-hand side of equality (3.24) shows that the mapping

$$L^{2}(I; L^{2}(\Omega)) \ni z \longrightarrow \frac{\partial}{\partial x} \left(a(x, t) \frac{\partial \mathfrak{I}_{t}(e^{c\tau} y)}{\partial x} \right)$$
(3.25)

is continuous if the function ω on the right-hand side of (3.24) verifies $a(\partial \omega/\partial x)$, $\mathfrak{I}_t^*(a(\partial \omega/\partial x)), (\partial/\partial x)(\mathfrak{I}_t^*(a(\partial \omega/\partial x))) \in L^2(I;L^2(\Omega))$ such that

$$\omega|_{x=\alpha} = \omega|_{x=\beta} = \frac{\partial \omega}{\partial x}\Big|_{x=\alpha} = \frac{\partial \omega}{\partial x}\Big|_{x=\beta} = 0.$$
(3.26)

Set

$$\omega = -2\mathfrak{I}_x^2 y. \tag{3.27}$$

It is easy to see that ω defined in (3.27) verifies conditions (3.26). We now substitute (3.27) into (3.24), and we get

$$-2(e^{ct}y,\mathfrak{I}_{x}^{2}y)_{L^{2}(I;L^{2}(\Omega))} = -2\left(\frac{\partial}{\partial x}\left(a\frac{\partial\mathfrak{I}_{t}(e^{ct}y)}{\partial x}\right),\mathfrak{I}_{x}^{2}y\right)_{L^{2}(I;L^{2}(\Omega))}.$$
(3.28)

Integrating by parts each term of (3.28) by taking into account conditions (3.4c), we have

$$-2(e^{ct}y,\mathfrak{I}_{x}^{2}y)_{L^{2}(I;L^{2}(\Omega))} = 2\int_{Q}e^{ct}(\mathfrak{I}_{x}y)^{2}dx\,dt, \qquad (3.29)$$

$$-2\left(\frac{\partial}{\partial x}\left(a\frac{\partial\mathfrak{I}_{t}(e^{c\tau}y)}{\partial x}\right),\mathfrak{I}_{x}^{2}y\right)_{L^{2}(I;L^{2}(\Omega))} = -\int_{\Omega}e^{-cT}a(x,T)(\mathfrak{I}_{T}(e^{ct}y))^{2}dx$$

$$\leq -\int_{\Omega}e^{-cT}a(x,T)(\mathfrak{I}_{T}(e^{ct}y))^{2}dx + \int_{Q}e^{ct}(\mathfrak{I}_{x}y)^{2}dx\,dt$$

$$-\int_{Q}e^{-ct}\left(ca-\frac{\partial a}{\partial t}-\left(\frac{\partial a}{\partial x}\right)^{2}\right)(\mathfrak{I}_{t}(e^{c\tau}y))^{2}dx\,dt. \qquad (3.30)$$

Substituting (3.29) and (3.30) into (3.28) yields

where $f_3(x,t,u) = f_1(x,t,u,w-u) - b_1(x,t)w$. Therefore, solving (1.1) is equivalent to solving (4.2) and to set

where $f_4(x,t,\sigma) = f_3(x,t,\sigma+U) + \mathcal{L}_1U$, $\sigma_0(x) = u_0(x) - U(x,0)$. We introduce the auxiliary problem

$$= -a_{1}\theta \cdot \Im_{x}\varpi\left|_{\alpha}^{\beta} + (a_{1}\theta(\cdot,t), \varpi(\cdot,t)) + \left(\frac{\partial a_{1}}{\partial x}\theta(\cdot,t), \Im_{x}\varpi(\cdot,t)\right),$$

from which we obtain

Integrating (4.22) over $(0, \tau)$ and performing a similar computation to that of the above, it follows that

THEOREM 4.4. Let assumptions of Theorem 4.3 be fulfilled. Then the limit function $\theta = \theta(x,t)$ is the weak solution of problem (4.6) in the sense of Definition 4.1.

To this end, we consider the weak formulation of problem (4.11), and set $\theta_n = (\theta_n - \theta) + \theta$ and $f(x, t, \theta_{n-1}) = (f(x, t, \theta_{n-1}) - f(x, t, \theta)) + f(x, t, \theta)$. Therefore, we get

$$\begin{pmatrix} \frac{\partial \theta_{n}(\cdot,t)}{\partial t} - \frac{\partial \theta(\cdot,t)}{\partial t}, \varpi(\cdot,t) \end{pmatrix}_{B_{2}^{1}(\Omega)} + \left(\frac{\partial \theta(\cdot,t)}{\partial t}, \varpi(\cdot,t) \right)_{B_{2}^{1}(\Omega)} + A(\theta_{n} - \theta, \varpi) + A(\theta, \varpi)$$

$$= \left(f\left(\cdot,t,\theta_{n-1}(\cdot,t)\right) - f\left(\cdot,t,\theta(\cdot,t)\right), \varpi\right)_{B_{2}^{1}(\Omega)} + \left(f\left(\cdot,t,\theta\right), \varpi(\cdot,t) \right)_{B_{2}^{1}(\Omega)},$$

$$\forall t \in I, \ \forall \, \varpi \in L_{0}^{2}(\Omega).$$

$$(4.38)$$

Thanks to the Schwarz inequality and inequality (2.3) for m = 1, the first and third terms on the left-hand side of (4.38) and the first term on the right-hand side can be majorized as follows:

$$\begin{split} \left(\frac{\partial\theta_{n}(\cdot,t)}{\partial t} - \frac{\partial\theta(\cdot,t)}{\partial t}, \varpi(\cdot,t)\right)_{B_{2}^{1}(\Omega)} &\leq \left\| \left|\frac{\partial\theta_{n}(\cdot,t)}{\partial t} - \frac{\partial\theta(\cdot,t)}{\partial t}\right\|_{B_{2}^{1}(\Omega)} \|\varpi(\cdot,t)\|_{B_{2}^{1}(\Omega)} & (4.39) \\ &\leq \frac{|\beta - \alpha|}{\sqrt{2}} \left\| \left|\frac{\partial\theta_{n}(\cdot,t)}{\partial t} - \frac{\partial\theta(\cdot,t)}{\partial t}\right\|_{B_{2}^{1}(\Omega)} \|\varpi(\cdot,t)\| & \forall t \in I, \\ A(\theta_{n} - \theta, \varpi) &= (a_{1}(\theta_{n}(\cdot,t) - \theta(\cdot,t)), \varpi(\cdot,t)) \\ &+ \left(\frac{\partial a_{1}}{\partial x}(\theta_{n}(\cdot,t) - \theta(\cdot,t)), \Im(\cdot,t)\right) \\ &- (b_{1}(\theta_{n}(\cdot,t) - \theta(\cdot,t)), \varpi(\cdot,t))_{B_{2}^{1}(\Omega)} \\ &\leq \left(c_{1} + \frac{|\beta - \alpha|}{\sqrt{2}}c_{3} + \frac{(\beta - \alpha)^{2}}{2}c_{4}\right) ||\theta_{n}(\cdot,t) - \theta(\cdot,t)|| ||\varpi(\cdot,t)|| \quad \forall t \in I, \\ (4.40) \end{split}$$

$$(f(\cdot,t,\theta_{n-1}(\cdot,t)) - f(\cdot,t,\theta(\cdot,t)), \omega(\cdot,t))_{B_{2}^{1}(\Omega)}$$

$$\leq \frac{|\beta - \alpha|}{\sqrt{2}} ||f(\cdot,t,\theta_{n-1}(\cdot,t)) - f(\cdot,t,\theta(\cdot,t))||_{B_{2}^{1}(\Omega)} ||\omega(\cdot,t)||$$

$$\leq \frac{(\beta - \alpha)^{2}}{2} L ||\theta_{n-1}(\cdot,t) - \theta(\cdot,t)|| ||\omega(\cdot,t)|| \quad \forall t \in I.$$

$$(4.41)$$

If we pass to the limit in (4.38) when $n \to \infty$ by taking into account (4.39), (4.40), and (4.41), we obtain the integral identity

$$\left(\frac{\partial\theta(\cdot,t)}{\partial t}, \omega(\cdot,t)\right)_{B_{2}^{1}(\Omega)} + A(\theta,\omega) = \left(f(\cdot,t,\theta), \omega(\cdot,t)\right)_{B_{2}^{1}(\Omega)} \quad \forall t \in I,$$
(4.42)

and the proof is complete.

4.5. Uniqueness of the solution. Assume that problem (4.6) admits two weak solutions θ_1 and θ_2 in $L^2(I; L^2_0(\Omega))$. Set $z = \theta_1 - \theta_2$. Then *z* satisfies

$$\frac{\partial z}{\partial t} - \frac{\partial}{\partial x} \left(a_1(x,t) \frac{\partial z}{\partial x} \right) - b_1(x,t) z = \Phi(x,t),$$

$$z(x,0) = 0,$$

$$\int_{\Omega} x^k z(x,t) dx = 0 \quad (k = 0,1),$$
(4.43)

with

$$\Phi(\mathbf{x},t) = f(\mathbf{x},t,\theta_1) - f(\mathbf{x},t,\theta_2). \tag{4.44}$$

Proceeding as in the establishment of estimate (4.20), we obtain

$$\|z\|_{L^{2}(I;L^{2}_{0}(\Omega))} \leq Lc_{6}\|z\|_{L^{2}(I;L^{2}_{0}(\Omega))},$$
(4.45)

where c_6 is the same constant defined in (4.20). Since $Lc_6 < 1$ (see (4.29)), then

$$\|z\|_{L^{2}(I;L^{2}_{0}(\Omega))} = \|\theta_{1} - \theta_{2}\|_{L^{2}(I;L^{2}_{0}(\Omega))} = 0,$$
(4.46)

from which we have the following theorem.

THEOREM 4.5. Assume that assumptions of Theorem 4.2 are fulfilled. Then the solution of problem (4.6) is unique.

4.6. Continuous dependence of the solution

THEOREM 4.6. If $\sigma(x,t)$ and $\sigma^*(x,t)$ are two solutions of problem (4.4) corresponding to (σ_0, f_4) and (σ_0^*, f_4^*) , respectively, and if there exist a continuous nonnegative function K(t) and a positive constant L such that the estimate

$$\left\| f_4(\cdot, t, \sigma) - f_4^*(\cdot, t, \sigma^*) \right\|_{B_2^1(\Omega)} \le K(t) + L \left\| \sigma - \sigma^* \right\|_{B_2^1(\Omega)}$$
(4.47)

holds for all σ , $\sigma^* \in B_2^1(\Omega)$ and all $t \in I$, then

$$\left|\left|\sigma(\cdot,\tau) - \sigma^{*}(\cdot,\tau)\right|\right|_{B_{2}^{1}(\Omega)}^{2} \leq \left(\left|\left|\sigma_{0} - \sigma_{0}^{*}\right|\right|_{B_{2}^{1}(\Omega)}^{2} + \int_{0}^{\tau} K^{2}(t)dt\right)e^{c_{11}T},\tag{4.48}$$

where $c_{11} = \exp((1 + 2L + 2c_4^2 + c_3^2/2c_0)T)$.

Proof. Let $s(x,t) = \sigma(x,t) - \sigma^*(x,t)$. Then s(x,t) satisfies

$$\mathcal{L}_{1}s = \frac{\partial s}{\partial t} - \frac{\partial}{\partial x} \left(a_{1} \frac{\partial s}{\partial x} \right) - b_{1}s = f_{4}(x, t, \sigma) - f_{4}^{*}(x, t, \sigma^{*}),$$

$$\ell_{1}s = s(x, 0) = \sigma_{0}(x) - \sigma_{0}^{*}(x) = s_{0}(x),$$

$$\int_{\Omega} x^{k}s(x, t)dx = 0, \quad k = 0, 1, t \in I.$$
(4.49)

Considering the weak formulation of problem (4.49), letting v = s, and integrating by parts, we obtain, by integrating the result over $(0, \tau)$,

$$\begin{aligned} ||s(\cdot,\tau)||_{B_{2}^{1}(\Omega)}^{2} + 2 \int_{0}^{\tau} (a_{1}s(\cdot,t),s(\cdot,t)) dt \\ &= 2 \int_{0}^{\tau} (f_{4}(\cdot,t,\sigma) - f_{4}^{*}(\cdot,t,\sigma^{*}),s(\cdot,t))_{B_{2}^{1}(\Omega)} dt + ||s_{0}||_{B_{2}^{1}(\Omega)}^{2} \\ &- 2 \int_{0}^{\tau} \left(\frac{\partial a_{1}}{\partial x}s(\cdot,t), \mathfrak{I}_{x}s(\cdot,t) \right) dt + 2 \int_{0}^{\tau} (b_{1}s(\cdot,t),s(\cdot,t))_{B_{2}^{1}(\Omega)} dt. \end{aligned}$$
(4.50)

Invoking assumption (A4) and (4.47) and applying the Cauchy inequality and Gronwall's lemma, we obtain inequality (4.48). \Box

5. Conclusion

In this paper, we have treated a nonlinear parabolic system with only integral terms in the boundaries. We have firstly solved a similar linear problem corresponding to a single parabolic equation. Then, on the basis of the obtained results, we have constructed via an iterative process a sequence of solutions and we have proved that this sequence converges to the weak solution of the problem under study.

Our results still hold for nonlinear 2m-parabolic systems with only integral conditions

$$\begin{aligned} \mathscr{L}_{1}(u,v) &= \frac{\partial u}{\partial t} + (-1)^{m} \frac{\partial^{2m-1}}{\partial x^{2m-1}} \left(a_{1} \frac{\partial u}{\partial x} \right) + b_{1}v = f_{1}(x,t,u,v), \\ \mathscr{L}_{2}(u,v) &= \frac{\partial v}{\partial t} + (-1)^{m} \frac{\partial^{2m-1}}{\partial x^{2m-1}} \left(a_{2} \frac{\partial v}{\partial x} \right) + b_{2}u = f_{2}(x,t,u,v), \\ \ell_{1}u &= u(x,0) = u_{0}(x), \\ \ell_{2}v &= v(x,0) = v_{0}(x), \\ \int_{\Omega} x^{k}u(x,t)dx &= m_{k}(t) \quad (k = \overline{0,2m-1}), \\ \int_{\Omega} x^{k}v(x,t)dx &= \mu_{k}(t) \quad (k = \overline{0,2m-1}); \end{aligned}$$
(5.1)

by using the same method, it suffices to replace in the proofs of corresponding theorems the space $B_2^1(\Omega)$ by $B_2^m(\Omega)$.

Our results can also be extended to a mixed problem for a pluriparabolic system with integral boundary conditions (or more generally for a pluriparabolic system with nonlocal initial conditions and integral boundary conditions, resp.):

$$\begin{aligned} \mathscr{L}_{1}(u,v) &= \sum_{i=1}^{n} \frac{\partial u}{\partial t_{i}} + (-1)^{m} \frac{\partial^{2m-1}}{\partial x^{2m-1}} \left(a_{1} \frac{\partial u}{\partial x}\right) + b_{1}v = f_{1}(x,t,u,v), \\ \mathscr{L}_{2}(u,v) &= \sum_{i=1}^{n} \frac{\partial v}{\partial t_{i}} + (-1)^{m} \frac{\partial^{2m-1}}{\partial x^{2m-1}} \left(a_{2} \frac{\partial v}{\partial x}\right) + b_{2}u = f_{2}(x,t,u,v), \end{aligned}$$
(5.2)
for $x \in \Omega$, $t = (t_{1},...,t_{n}) \in \prod_{i=1}^{n} (0,T_{i}), \\ (\mathscr{L}_{1}(u,v) &= \sum_{i=1}^{n} \frac{\partial u}{\partial t_{i}} + (-1)^{m} \operatorname{sign} \prod_{i=1}^{n} \left(1 - |\lambda_{i}|^{2}\right) \frac{\partial^{2m-1}}{\partial x^{2m-1}} \left(a_{1} \frac{\partial u}{\partial x}\right) + b_{1}v \\ &= f_{1}(x,t,u,v), \\ \mathscr{L}_{2}(u,v) &= \sum_{i=1}^{n} \frac{\partial v}{\partial t_{i}} + (-1)^{m} \operatorname{sign} \prod_{i=1}^{n} \left(1 - |\lambda_{i}|^{2}\right) \frac{\partial^{2m-1}}{\partial x^{2m-1}} \left(a_{2} \frac{\partial v}{\partial x}\right) + b_{2}u \\ &= f_{2}(x,t,u,v), \quad \text{for } x \in \Omega, \ t = (t_{1},...,t_{n}) \in \prod_{i=1}^{n} (0,T_{i}), \quad \text{resp.}), \\ \ell_{i}u &= u(x,t_{1},...,t_{i-1},0,t_{i+1},...,t_{n}) = u_{0i}(x,t_{1},...,t_{i-1},t_{i+1},...,t_{n}), \\ \ell_{i}v &= v(x,t_{1},...,t_{i-1},0,t_{i+1},...,t_{n}) \in \Omega \times \prod_{\substack{j=1\\ j \neq i}}^{n} (0,T_{j}), \\ (t,t_{1},...,t_{i-1},t_{i+1},...,t_{n}) - \lambda_{i}u(x,t_{1},...,t_{i-1},T_{i},t_{i+1},...,t_{n}) \\ &= u_{0i}(x,t_{1},...,t_{i-1},0,t_{i+1},...,t_{n}) - \lambda_{i}v(x,t_{1},...,t_{i-1},T_{i},t_{i+1},...,t_{n}) \\ = v_{0i}(x,t_{1},...,t_{i-1},t_{i+1},...,t_{n}), \\ \ell_{i}v &= v(x,t_{1},...,t_{i-1},0,t_{i+1},...,t_{n}) - \lambda_{i}v(x,t_{1},...,t_{i-1},T_{i},t_{i+1},...,t_{n}) \\ &= v_{0i}(x,t_{1},...,t_{i-1},t_{i+1},...,t_{n}), \end{cases}$ (5.5)

$$(x, t_{1}, \dots, t_{i-1}, t_{i+1}, \dots, t_{n}) \in \Omega \times \prod_{\substack{j=1 \ j \neq i}}^{n} (0, T_{j}), \quad \text{resp.}),$$

$$\int_{\Omega} x^{k} u(x, t_{1}, \dots, t_{n}) dx = m_{k}(t_{1}, \dots, t_{n}),$$

$$\int_{\Omega} x^{k} v(x, t_{1}, \dots, t_{n}) dx = \mu_{k}(t_{1}, \dots, t_{n}),$$

$$(t_{1}, \dots, t_{n}) \in \prod_{i=1}^{n} (0, T_{i}), \quad (k = \overline{0, 2m - 1}).$$

By using the same reasoning given above, it is enough to put the test function $\sum_{i=1}^{n} (\partial z / \partial t_i)$ instead of $\partial z / \partial t$ and to use a generalization of Gronwall's lemma appropriate to this type problems; see, for instance, [4].
